Entry Requirements

- 1. The applicants should be other than Chinese national and hold a valid passport, he or she should be in good health and has no criminal record, and willing to abide by the law of the People's Republic of China and the regulations of Jilin University;
- 2.Applicants who apply for Bachelor program should hold high-school degrees; applicants who apply for Master program should hold Bachelor degree and be aged under 40; applicants who apply for Doctor program should hold Master degree and be aged under 50.
- 3. The applicants should have adequate English proficiency so as to engage in efficient classroom learning.

Introduction of the School of Economics

The history of the School of Economics of Jilin University can trace back to 1946. With a long period of construction and development, Economics School was established by integrating the economics subjects of other universities. The School of Economics has achieved striking success in several aspects such as discipline construction, faculty building, talents cultivation and scientific research.

There are various programs and majors in the School of Economics: four undergraduate majors, namely, Economics, International Economy and Trade, Public Finance (including Taxation) and Finance (including Insurance); 14 academic master degree programs, namely, Political Economy, World Economy, Western Economics, Economic History, History of Economic Thought, National Economics, Industrial Economics, Finance, International Trade, Public Finance, Accounting, Corporate Management, Institutional Economics and Law and Economics; 5 professional master degree programs, namely, Master of Taxation, Master of Finance, Master of International Business, Master of Project Management and Master of Industrial Engineering; 8 doctoral degree programs, namely, Political Economy, World Economy, Western Economics, Institutional Economics, Law and Economics, History of Economic Thought, Finance and Industrial Economics and a center for post-doctoral studies of theoretical economics. In 1994 and 2002, the Political Economy and the World Economy were rated as key subjects of regular higher education in Jilin Province. In 1998, the School of Economics set up a "National Cultivation Base of Economics Talents" with the approval of the Ministry of Education. In 2000, the Theoretical Economics won the authority to confer doctoral degree of first-level discipline with the approval of the Academic Degree Commission of the State Council. In the same year, the "China Center for Public Sector Economy Research" became a national key research base for humanistic and social sciences approved by the Ministry of Education.
